Executive Directors Report

- Martin House is celebrating their 39th Anniversary on Wednesday, June 30th at 3:30 pm at Martin House. The event is rain or shine. Any Director on the Board is invited and may choose to say a few words.
- The Conflict of Interest was sent out to all Board Directors. Please sign and return to Paula.
- Cara-Lynn will be awarded the 2021 Daniel Jenkins Memorial Award at the June 18^{th,} NAACP, Juneteenth commemoration and flag raising in front of the Norwich City Hall. We all congratulate her.
- Paula is asking for the Board to act on a DMHAS Resolution for the 2021-2022 Contract, giving Paula Oberg and Gayle O'Neill authorization to enter and amend contractual instruments with the Department of Mental Health and Addiction Services of the State of Connecticut. This applies to the Martin House Recovery for Life Program. Theresa makes a motion to approve, Deb 2nds. Motion passes.

Executive Directors Report Martin House July 2021

The Martin House 39th Anniversary was enjoyed by all. Our event took place on the patio with Karl and Brian grilling chicken and hotdogs. They had made some great summer salads! Beverages and ice cream sundaes for dessert were complimented by a MH cake. I had announced my leaving to residents a day before the anniversary and included a bit of farewell and thanks for the opportunity in my speech. Thus far the residents are being very complimentary and wish me the best. They are most interested in who will be replacing me. I let them know there was a search taking place and as soon as I know something I will pass it on.

We have done some year end facility deep cleaning during the past month. A combination of year end DMHAS money and additional grants we received due to COVID have been used to clean the kitchen and dining room, both stairways and walls, lounge and have had the floors waxed and buffed. We are turning in our front loading washers and dryers in exchange for top loaders. This is in response to flooding in the laundry room due to the front loader doors not being completely closed. This change has also resulted in a vendor change with the goal of getting a quicker response when a machine is in disrepair. We were able to keep the cost to residents unchanged, a benefit for them.

Both Housing Supports and Recovery for Life are doing well. Even though 99.9% of residents and staff have been completely vaccinated we are still wearing masks in the building. This is required by State of CT, Department of Administrative Services. We continue to be vigilant for any signs or symptoms of illness for both groups.

Regrets for not including good news about receiving our United Way Letter of Award in last month's report. We will receive a total of \$121,556 for the coming year. The amount is but \$54 less than last year. We had prepared ourselves to be significantly cut based on what the staff of United Way had been reporting. I am in the process of putting together info for the final report due August 31st.

I will be on vacation beginning 7/23 returning 8/9. Lori, Constance, Karl, and Astrid will be the responsible staff, as they are whether I am on vacation or not! Although I prefer to not be called upon to respond to work, I will be in the area and available by phone, 860-949-4659.
